CREATION OF A WOMEN’S DEPARTMENT
Reference Committee and Chile Bio Bio District Assembly

RESOLVED that the appropriate General Board committee be assigned to study the creation of a Women’s Department in the Church of the Nazarene.

REASONS:

1. To materialize into actions the acknowledgement of the Church of the Nazarene that women, just as men are biblically called to perform a leading role in the building of God’s kingdom.
2. The Church of the Nazarene acknowledges women’s role of leadership in paragraph 903.5 and others in the *Manual*.
3. Women’s role of protagonist leadership has been growing gradually in the life and practice of the Church at every level: local district, regional and general.
4. The expansion of women’s potential leadership in today’s world at the political, social, economic and spiritual levels is undeniable, and it can be even more prosperous in the Church.
5. The Church of the Nazarene requires that women’s leadership in the Church at local and district levels be recognized and represented, just as in Sunday School and Discipleship Ministries International, Nazarene Missions International, and Nazarene Youth International.

9 RESOLVED that *Manual* paragraph 339 be amended as follows:
10

11 O. Committee on the Interests of the God-Called Evangelist

12 339. The Committee on the Interests of the God-Called Evangelist shall
13 be composed of the revivalism coordinator, a tenured evangelist appointed by
14 the Board of General Superintendents, who shall be ex-officio chairperson of
15 the committee, plus four tenured evangelists and one pastor. The USA/Canada
16 Mission/Evangelism director, in consultation with the revivalism coordinator
17 shall submit a list of nominees for the committee to the Board of General
18 Superintendents for approval and appointment. The committee or its designee
19 shall personally interview commissioned evangelists who have been
20 recommended by their respective district assemblies for "tenured evangelist"
21 status (408.3). It shall also review the state of itinerant evangelism in the
22 Church of the Nazarene and make recommendations concerning both revivals
23 and evangelists to the appropriate committee of the General Board. Vacancies
24 shall be filled by appointment from the Board of General Superintendents from
25 recommendations received from the USA/Canada Mission/Evangelism director,
26 in consultation with the revivalism coordinator. (317.7)
